Welfare Reform in Northern Ireland

As you may be aware, Welfare Changes will result in changes to the benefits system in Northern Ireland. Some of the current benefits will cease to exist and new benefits and payment systems will be introduced.

What is the Bedroom Tax

Social Sector Size Criteria (the 'bedroom tax') is a new criteria to calculate housing benefit payments.

What does the change mean?

The amount of Housing Benefit paid to people of working age will be changed to reflect the size of their family. Tenants of all social landlords will have their Housing Benefit payments reduced if they have more bedrooms in their home than their family needs. The new rules will allow one bedroom for:

- Each adult couple
- Any other adult aged 16 or over
- Any two children of the same sex aged under 16
- Any two children aged under 10 regardless of gender
- Any other child (other than a foster child or child whose main home is elsewhere)
- A carer (or team of carers) who do not live with the claimant but provide overnight care.

How might you be affected

If you are considered to have more bedrooms than you need, your Housing Benefit will be reduced by:

14% if you are considered to have more bedrooms than you need.

25% for under-occupying by two or more bedrooms.

This will affect all claimants of working age. People over pension age will not be affected by the bedroom tax. If your Housing Benefit is reduced because of Social Sector Size Criteria, a Welfare Supplementary Payment will be available until 31 March 2020.
